At the end of this period the consignor may reclaim any unsold item(s) within 7 days. The consignor is responsible for making arrangements for collection of those items. Any items not picked up by this date will become the property of **Infiniti Fine Consignments** or donated to Brothers Keeper. (Initial: _____) We **DO NOT** call you.

Infiniti Fine Consignments will price your items based on our knowledge of the marketplace and our store/area. It is understood and agreed to by the Consignor the retail selling price of Consignor's merchandise will be established by **Infiniti Fine Consignments** and is normally 50 % or less of its original retail purchase price.

FEES:

Furniture / Accessories:

- Consignor receives 50 % of the actual selling price (less sales tax, delivery charges, etc)
- **Infiniti Fine Consignments** receives 50 % of the actual selling price.
- There will be a 50 cent administration charge on all checks issued.

Clothing:

- Consignor receives 50 % of the actual selling price (less sales tax).
- **Infiniti Fine Furniture** receives 50 % of the actual selling price.

PAYMENTS:

- Consignor is responsible for contacting the store for account balance, and payment arrangements.
- Checks will be issued on the 15th day of the month for prior month's sales.
- Checks not cashed within 90 days will automatically be cancelled with loss to the Consignor.

PICK UPS:
